

MEETING THE MOMENT

ANSWERING THE CALL OF RISING HEALTHCARE COSTS

On June 7th, the Board of Trustees unanimously approved a \$200,000 increase to the annual grant to the Conference Board of Pensions, raising this year's total gift to \$2.2 million.

Rising healthcare costs continue to place a significant burden on retirees across the country; a burden that our retired clergy and their spouses should not have to bear alone.

In faithful alignment with our mission, The Endowment Board is committed to responding to the evolving needs of the retired clergy. While many conferences are scaling back or eliminating benefits, the California-Nevada Conference is expanding theirs and this is only possible because of our donors' trust and support.

We remain deeply honored to serve as stewards of the funds we receive, ensuring that those who served others are not forgotten in retirement, but cared for with dignity, love, and tangible support.



Making Annual Conference More Accessible for Retirees

Navigating the Annual Conference Session often involves a lot of walking between sessions, meals, and gatherings. To help make the experience more comfortable and inclusive, The Endowment Board sponsored complimentary scooter rentals for all retirees and their spouses who wished to reserve one.

Scooters were delivered onsite and available throughout the weekend, ensuring that physical limitations didn't prevent anyone from participating fully in the event. Whether attending a worship service, joining a meal, or connecting with colleagues, retirees were able to move freely and comfortably.

The Endowment Board remains committed to removing barriers and supporting the well-being of retired clergy—because no one should have to miss out due to mobility challenges.

\$5,000 Gathering of the Spiritual Leaders Sponsorship

In October 2024, The Endowment Board trustees approved a \$5,000 sponsorship for the 2025 Gathering of Spiritual Leaders (GOSL) with a dual purpose: to enhance programming for retired clergy and to foster relationships with active clergy.

This year's sponsorship brought meaningful experiences to retired clergy attending the event by creating a nurturing environment to tend to their mental and spiritual well-being. Highlights included complimentary tickets to the Monterey Bay Aquarium, a sound bath experience, and support for the Bishop's reception at Bubba Gump's, where an Endowment Board banner was proudly displayed.

This sponsorship came in addition to the \$136,000 annual grant to the Retired Clergy Association, which funded per diems for over 40 retirees and their spouses to attend GOSL.

Feedback from attendees was overwhelmingly positive, reflecting the impact of these efforts in honoring retired clergy and deepening engagement across generations of spiritual leadership.

THE SHEPHERD FUND offsets costs for retired clergy and spouses in times of need. Asking for help can be difficult for those who have chosen a life of service and selflessness, but the hope is that those who qualify will see the fund as a blessing. The Shepherd Fund is confidentially administered by the Conference Board of Pensions office.

In 2024, numerous Shepherd Fund grants were issued to deserving individuals, totaling \$19,000. The funds were used to help offset costs for unexpected medical conditions, a cross-country move, travel to a loved one's funeral, end of life care, and caregiver respite care.

WISDOM IN SCHOLARSHIP & EDUCATION (WISE) FUND

On February 6th, 2025, The Endowment Board's Board of Trustees approved the launch of the Wisdom in Scholarship & Education (WISE) Fund - a new initiative dedicated to ensuring that all retired clergy have access to continuing education, fellowship opportunities, and other

endeavors that would facilitate spiritual growth. The WISE Fund removes any potential financial obstacles for retirees to pursue meaningful studies, engage in spiritual exploration, and continue sharing their wisdom with their communities.

THE HEALTHCARE FUND is used to help fund the \$2.2M annual grant to the Conference Board of Pensions. These funds help retirees cover the financial gap that emerges when Medicare falls short. Some of the funds are distributed via an HRA card that retirees and spouses can use to cover any medical expenses, including their Medicare Part B premiums.

THE AREA OF GREATEST NEED leaves the designation up to the discretion of The Endowment Board, and the highest priority at the time the gift is made.



A SMART WAY TO GIVE

QUALIFIED CHARITABLE DISTRIBUTIONS IN 2025

If you're age $70\frac{1}{2}$ or older, there's a powerful tool available to support your charitable giving while also reducing your tax burden: the Qualified Charitable Distribution (QCD).

With the increased standard deduction, fewer taxpayers itemize their deductions, meaning traditional charitable gifts may no longer reduce your taxable income. But QCDs offer a way around that.



Reduces taxable income, satisfies RMDs, no need to itemize deductions

What Is a QCD?

There is no minimum amount, a QCD allows you to make a tax-free donation directly from your traditional IRA to a qualified charity, such as The Endowment Board or your local church. This donation can count toward your Required Minimum Distribution (RMD), which begins at age 73. For 2025, you can donate any amount up to \$108,000 through QCDs.

Tax Benefits:

- · Reduces your Adjusted Gross Income (AGI), which can lower your overall tax liability.
- · May reduce the taxable portion of your Social Security benefits.
- · Helps avoid the "stealth taxes" triggered by higher AGI, such as increased Medicare premiums.


Most financial advisors are familiar with QCDs and can help you initiate the process. It's a simple, impactful way to support the causes you care about, while making the most of your retirement assets.

LEAVING A LEGACY

GRATITUDE IN ACTION

Legacy giving, also known as planned giving or deferred giving, allows you to achieve your personal, financial, and philanthropic goals, and make a larger gift to a charity than you could make from ordinary income. Common types of planned gifts include charitable bequests, IRA charitable rollovers, charitable remainder trusts, retirement assets, pooled income fund contributions, and blended gifts.

The Legacy of Mr. Edward T. Bernhoft



Mr. Edward Bernhoft, a devoted layperson in the California-Nevada Conference, deeply believed in the mission of The Endowment Board and wanted to ensure its continued support for retired clergy and their spouses. With just a single sentence in his will, he made a lasting impact—designating a \$10,000 gift to The Endowment Board as part of his estate plan. His daughter, Joyce, later requested that the funds be directed to the Shepherd Fund, honoring what she knew to be her father's heartfelt intention. We are profoundly grateful to be the beneficiaries of Mr. Bernhoft's simple yet powerful act of generosity...his Gratitude in Action.

The Endowment Board's Pooled Income Fund Income for Life with a Side of Philanthropy

The Endowment Board's Pooled Income Fund (PIF) is a separate charitable trust fund managed by estate planning attorneys at Hobson and Hobson. When people generously contribute to our PIF, they receive immediate tax and income benefits for life. The PIF works like this:

- · Contributions are pooled with those of other donors and invested in our fund
- · Income is paid quarterly based on interest in the fund
- · Upon passing, the remaining funds will go to help further our mission

In 2024, our PIF participants received a 6.5% overall rate of return*

*Numbers vary depending on the performance of the fund.




